INDIVIDUAL NEEDS INCLUDE COGNITIVE LIMITATIONS, BEHAVIORAL ISSUES, MENTAL HEALTH, AND SOCIAL CHALLENGES. 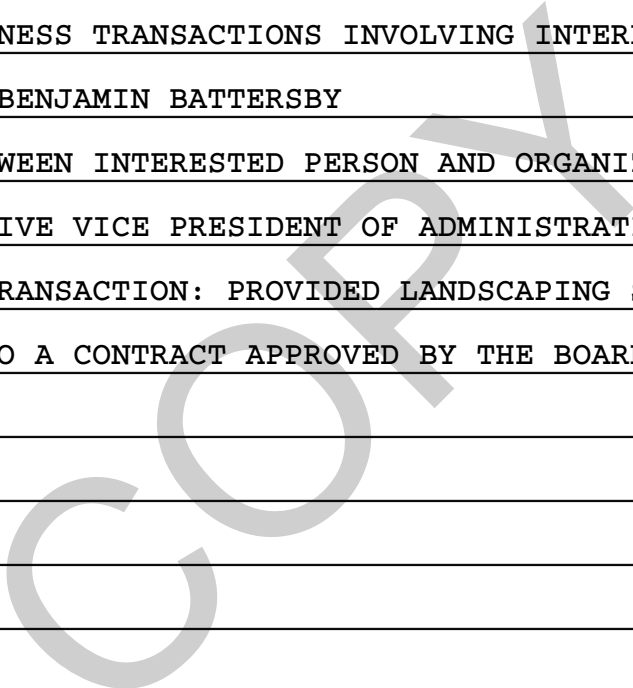

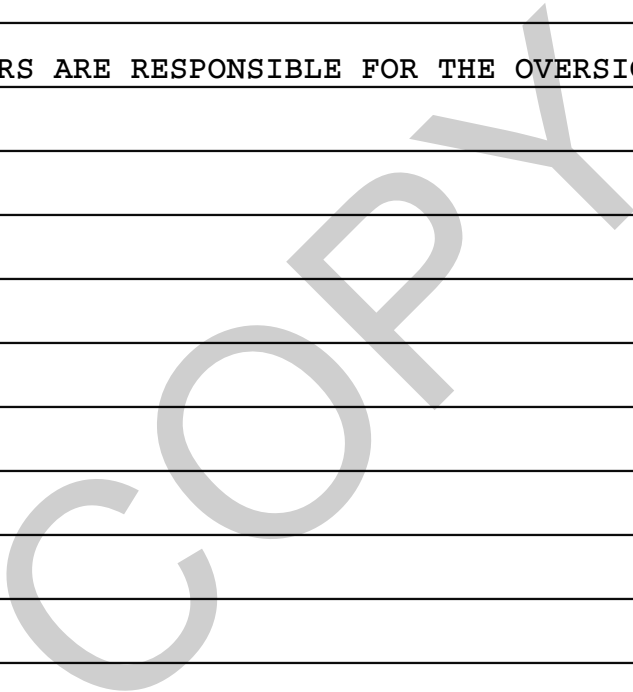
